Sub: **Guidance Workshop on Institutional Eligibility & Institutional Development Proposal (IDP) for participation in Sub Component 1.1 "Strengthening institutions to Improve Learning Outcomes and Employability of Graduates" of TEQIP – II.**

Dear Sir/Madam,

The process of selection of States to participate in TEQIP II has been completed and intimated to the respective States on 30th June 2010.

The advertisement for selection of institution to participate in Sub Component 1.1 has already been issued in all editions of the Times of India, the Indian Express and the Navbharat Times dated 30th June 2010. The last date for submission of Institutional Eligibility Proposals to respective SPFUs is 23rd July 2010. The States have also been requested to issue advertisement in this regard accordingly.

NPIU is organizing a Guidance Workshop on 15th July 2010 at Radisson Hotel, Sector 18, Noida (U.P.) from 1030 hrs to 1730 hrs. The inputs will be given by NPIU and World Bank officials.

The objective of the Workshop is to familiarize the prospective participants with the Project and, Eligibility and IDP formats to help them prepare meaningful and satisfactory proposals. The agenda for the Workshop is given below:

- a. Presentation on TEQIP – II
- b. Eligibility Proposal – eligibility conditions, requirements and concepts
- c. Institutional Development Proposal (IDP) – requirements and concepts
- d. Evaluation of proposals – methodology

The Workshop is expected to be attended by one SPFU official and one Institute official. The SPFU official would be the Project Coordinator. The Institute official is expected to be the TEQIP Coordinator/Institute Principal (Director). In this regard, you are kindly requested to notify to all the prospective Institutions to attend the Guidance Workshop.

Please forward the names of the officials attending from institutions and the DTE / SPFU of the State by 13th July 2010 positively.

For attending the Workshop, each Institution official will make his / her own arrangements for travel, lodging, boarding and conveyance. The expenditure so made will not be reimbursable under TEQIP – II.
